



MEMORANDUM OF UNDERSTANDING

2. **Term of MOU:** This MOU is effective from 14th August 2021 till 30th July 2022.

3. **Responsibilities of Aspire For Her:**

As per the understanding between Aspire For Her and ATME College of Engineering, the following are the deliverables from Aspire For Her's side :

- Aspire For Her to provide 2 webinars (online mode only) a year specific to the college. One immediately on sign up of the students and the other webinar in the latter half, both based on the speakers availability. Besides this, the students of the said college are free to attend all the webinars arranged for the other colleges on our platform .
- Aspire For Her to provide 1:1 mentorship to girls of the college who wish to get connected to mentors for career advice on our platform absolutely free of charge.
- Students(boys and girls) can use all the resources on Aspire For Her platform absolutely **free** of charge. All our resources are available on **online** mode only.
- Students(boys and girls) can avail of all the job and internship opportunities that are advertised on our platform based on eligibility. It is however the final decision of the employer to decide about giving jobs/internships to the students.



4. **Responsibilities of college name) :**

As per the understanding, following are the deliverables from the side of College :

- This program is being launched for the cohort of students as agreed between the College and Aspire For Her
- College to designate POC(s) from their side, one teacher and 2 girl students. The College to provide the details of the POC(s) (name, gender, stream, mobile and email address). POCs will provide coordination, communication, dissemination of information, etc. to students.
- The College can include some courses(to be decided by the College and online mode only) from Open P-Tech(digital badges provided) as a compulsory offering to the students, relevant MOU to be signed. Please note that this offering is free of cost.




